- 3. The Promotion of Shri Shashi Bhushan Shukla (99015), presently on deputation, shall take effect on his reversion / reporting back to the Board.
- 4. The Local Placement Committee in the region of the Cadre Controlling CC&IT shall ensure that further placement of the officers are done strictly in accordance with the provisions of the Transfer / Placement Policy taking into account interalia, the nature of officer in Class 'A' Station...
