**OFFICE ORDER NO. 184 OF 2020**


Consequent upon approval of the Competent Authority, Shri Nitin Gupta, IRS (86026), DGIT (Inv.), Mumbai is, hereby, promoted to the grade of Principal Chief Commissioner of Income Tax (Pr. CCIT) (Level 17 in the pay matrix Rs. 2,25,000/-) for the panel year 2020 on in-situ basis with effect from 01.10.2020 or the date on which he assumes charge of the post, whichever is later.

2. The promotion of Shri Nitin Gupta, IRS (86026) shall be on *ad-hoc* basis till the Sealed Cover cases of his senior officers are finalized or subsequent regular vacancies in the grade arise, whichever is earlier. On promotion, the officer shall continue to hold the charge, which he was holding before promotion, till his formal posting is ordered.
