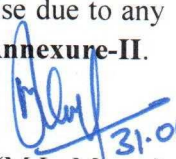

OFFICE ORDER No. 13/2019

The President is pleased to grant Non-Functional Selection Grade (NFSG) to officers of IRS (C&CE) in the grade of Joint Commissioner of Customs & Central Excise (i.e. Additional Commissioner of Customs and Central Excise), in the pre-revised Pay Band-4 (Rs.37,400-67000/-) with Grade Pay of Rs.8,700/- to the officers mentioned in the **Annexure-I** on ad-hoc basis, with effect from the date mentioned against their name. The officers (mentioned in Annexure. I) who are on deputation and are drawing pay in JAG are granted NFSG on proforma basis.

2. The grant of ad-hoc NFSG would be subject to the grant of regular NFSG by the competent authority based on the recommendations of regular Departmental Screening Committee.

3. The grant of NFSG is further subject to necessary undertaking to be given by the officer regarding the recovery of the excess payment, if any contingency arise due to any change in seniority. The proforma for giving the required undertaking is at **Annexure-II**.
