

Subject:-Filling up the post of Sepoy in Narcotics Control Bureau under Ministry of Home Affairs on Deputation Basis.

Narcotics Control Bureau, Ministry of Home Affairs, intends to fill up **20 (Twenty)** existing vacancies of Sepoy (Group-C, Non-Gazetted, Non Ministerial) in Level-1 of the Pay Matrix as per 7<sup>th</sup> CPC on deputation basis.
