Office Order No. 175/2019

The President of India is pleased to order that the officers of the Indian Revenue Service (Customs & Central Excise) mentioned in **Annexure-I** be promoted to the grade of Deputy Commissioner of Customs & Central Excise [in the pre-revised pay scale of Pay Band – 3 with Grade Pay of Rs. 6600/-] on ad-hoc basis with effect from 01.01.2020 or the date of assumption of charge of the post (not before 01.01.2020); whichever is later.

2. The President of India is also pleased to order that the officers of the Indian Revenue Service (Customs & Central Excise) mentioned in **Annexure-II** be promoted to the grade of Deputy Commissioner of Customs & Central Excise [in the pre-revised pay scale of Pay Band – 3 with Grade Pay of Rs. 6600/-] on ad-hoc basis with effect from 31.03.2020 or the date of assumption of charge of the post (not before 31.03.2020); whichever is later.

3. The promotion of the officers (whose name are mentioned in Annexure-I & II) to the grade of Deputy Commissioner of Customs and Central Excise is purely on ad-hoc basis, subject to the orders for regular promotion by the competent authority based on the recommendations of the DPC for regular promotion.

4. The names appearing in the Annexure-I & II are not in order of their seniority and also that the concerned officers will have no right to claim for regular promotion at a later stage when the regular promotion are made.

5. The ad-hoc promotion of the officers mentioned in Annexure-I & II to the grade of Deputy Commissioner of Customs and Central Excise shall not confer any right on the officers so promoted for any claim for regular promotion in the grade of Deputy Commissioner and the period of such service will not count for seniority or as qualifying service for further promotions.

6. The promotion of officers to the grade of Deputy Commissioner mentioned in Annexure-I & II are subject to related court cases, if any.

7. The promotion of the officers to the grade of Deputy Commissioner of Customs & Central Excise on ad-hoc basis who are currently on deputation outside the Department,

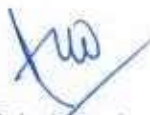
shall take effect only after they are repatriated to the cadre and report to the Board for joining the promotional post.

8. The officers being promoted through this Order shall assume the charge of the post of the Deputy Commissioner in the same office where they are currently posted.

9. The concerned Principal Chief Commissioners / Principal Directors General / Chief Commissioners / Director Generals / Principal Commissioners / Principal Additional Director General, CBIC shall ensure that if any of the officers whose name figure in Annexure-I & II to this order is under suspension or facing any charge sheet or prosecution, he/she should not be allowed to assume charge of the post of Deputy Commissioner and this fact should be reported to the Board immediately. Further, if any of the officers figuring in Annexure-I & II is undergoing any penalty, he/she should be allowed to assume the charge of the post of Deputy Commissioner only after the expiry of the currency of the penalty period. This fact may also be reported to the Board.

10. The Pr. Chief Commissioners/Pr. Directors General/Chief Commissioners/Directors General concerned shall send the compliance reports regarding joining of the officers at Annexure I to the Board [with a copy endorsed to ADG (HRM-II), DGHRD] by 06.01.2020 and that of officers mentioned in Annexure-II by 06.04.2020.
