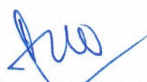

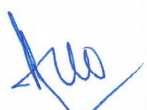
5. All the representations received till date regarding transfer and posting in the grades of Principal Commissioner/ Commissioner of Customs and Indirect Taxes stand disposed of.
