VACANCY CIRCULAR

Applications are invited from eligible and willing officers of the Indian Revenue Service and Indian Legal Service, Govt. of India, for appointment of 3 Members of the Adjudicating Authority, Principal Bench, New Delhi, established by the Central Government under Section 7 of the Prohibition of the Benami Transactions Act, 1988, (the PBPT Act), as per the provisions of the Prohibition of Benami Property Transactions (Conditions of Service of Members of Adjudicating Authority) Rules, 2019 (the PBPT Rules), on appointment basis. As per Section 9(3) of the PBPT Act, the Central Government shall appoint the senior-most Member to be the Chairperson of the Adjudicating Authority.

1) Qualification:

A person shall not be qualified for appointment as the Member of the Adjudicating Authority unless he,-

- has been a member of the Indian Revenue Service and has held the post of Commissioner of Income-tax or equivalent post in that Service; or
- has been a member of the Indian Legal Service and has held the post of Joint Secretary or equivalent post in that Service.

2) Term of Office of Members of Adjudicating Authority:

The Members of the Adjudicating Authority shall hold office for a term not exceeding five years from the date on which they enter upon their office, or until they attain the age of sixty-two years, whichever is earlier, and shall not be eligible for reappointment (Section 12 of the PBPT Act).

3) Salaries and allowances of the Chairperson and the Members:

In accordance with Rule 7 of the PBPT Rules, the Salaries and allowances of the Chairperson and the Members will be as follows:

(A) The Chairperson of the Adjudicating Authority shall be paid a salary of Rs. 1,82,200-2,24,100 and shall be entitled to draw allowances as are admissible to a Central Government Officer holding post carrying the same pay.

(B) The Member of the Adjudicating Authority shall be paid a salary of Rs. 1,44,200- 2,18,200 and shall be entitled to draw allowances as are admissible to a Central Government Officer holding post carrying the same pay.

(C) In case a person, appointed as the Member of the Adjudicating Authority, is in receipt of any pension, the pay of such person shall be reduced by the gross amount of pension drawn by him.

4) Accommodation:

The Chairman and Members shall not be eligible for allotment of general pool residential accommodation but they shall be entitled to draw house rent allowance at the rates as are admissible to other Central Government officers of equivalent pay. Provided that if the person appointed as Member is already in occupation of Government accommodation for which Central Government officers of equivalent pay are eligible, he shall be allowed to retain such accommodation from the date of his joining the Adjudicating Authority in view of Rule 11 of the PBPT Rules.

5) Medical Fitness:

No person shall be appointed as the Member of the Adjudicating Authority, unless they are declared medically fit by an authority specified by the Central Government (Rule 4 of the PBPT Rules).

6) As per Rule 17 of PBPT Rules, the appointment for the post of Members to the Adjudicating Authority, Principal Bench, New Delhi will be in accordance with the orders issued by the Central Government from time to time with regard to reservation, relaxation of age-limit and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes, Ex-servicemen and other special categories of persons.

7) For further details, the Prohibition of Benami Property Transaction Act, 1988 and the Prohibition of Benami Property Transactions (Conditions of Service of Members of Adjudicating Authority) Rules, 2019 may kindly be referred to.

8) The applications along with bio-data, only in the proforma enclosed, should reach the O/o Principal Director General, Directorate of HRD, Central Board of Direct Taxes, R.No.114, 2nd Floor, Gate No.1, Jawahar Lal Nehru Stadium, New Delhi-110 003, within 45 days from the date of publication of the vacancy advertisement in the Employment News. The applications received either after the last date or received in a format other than the enclosed format, are liable to be rejected. The Applicants in Government service, should furnish their applications through their Cadre controlling authority only, along with cadre clearance, vigilance clearance, and complete ACR/APAR dossiers. Incomplete applications will not be entertained.
