Subject:- Cadre Restructuring and re-organization of field formations under Central Board of Excise & Customs- allocation of revised cadre strength.

Sir/Madam,

I am directed to invite reference to the Board's letter of even number dated 1st August, 2014, on the subject mentioned above and to say that pursuant to the stipulations in Para 6 of the said letter, the apportionment of zone-wise sanctioned strength in the grades of Superintendent and Inspectors to the Directorates General/Directorates, out of the strength sanctioned to the respective CCOs shall be as indicated in the statement at **Annexure 'A'**.

2. The period of posting to Directorate (HQs./Zonal/Regional/Sub-Regional Units) of the officers from CCOs on local rotational transfer basis will be for a minimum period of 2 years initially. Further, salary of the officers from CCOs posted to Directorates will continue to be drawn from the budgetary head of the concerned CCO. Officers from CCOs posted to different Directorates will not be entitled to any special pay/deputation allowance.

3. Vacancies in the Zonal Cadres will be proportionately shared between Cadre Controlling Zones and Directorates.

4. The Working Staff Strength that will be made available to different Directorates from CCOs will be over and above the staff strength allocated in the Superintendent and Inspector level posts to these Directorates, vide Staff Allocation order dated 01.08.2014.

5. Two LTU Audit Commissionerates (one each for Delhi and Mumbai LTUs) will cater to the Audit needs of the other three LTUs also through Audit Circles in these LTUs. Mumbai LTU Audit will cater to the Audit needs of Chennai LTU through Audit Circle in Chennai. Similarly, Delhi LTU Audit Commissionerates will attend to Audit work of LTUs at Kolkata and Bangalore through Audit Circles at Kolkata and Bangalore.
