1. **Secretariat - Social Services:** Provides for the Secretariat service to the Department of Indian Systems of Medicine and Homoeopathy.

2. **Ayurveda:** Includes provision for (i) National Institute of Ayurveda, Jaipur which serves as a model institute for teaching, training, research and patient care, (ii) Central Council for Research in Ayurveda and Siddha and (iii) maintenance and development grants-in-aid to Institute of P.G. Training and Research, Jamnagar, a constituent of Gujarat Ayurvedic University and Rashtriya Ayurveda Vidyapeeth, New Delhi.

3. **Homoeopathy:** Includes provision for Central Council for Research in Homoeopathy, grants to National Institute of Homoeopathy, Calcutta, which is an autonomous organisation, and grant for upgradation of Homoeopathic Post-Graduate Colleges, apart from provision for Homoeopathic Pharmacopoeial Laboratory, Ghaziabad, a subordinate office under the Department.

4. **Unani:** Includes provision for (i) Central Council for Research in Unani Medicine (ii) National Institute of Unani Medicine, Bangalore (a model Institute for teaching, training, research and public health care) which are autonomous organisations fully financed by the Government.

5. **Yoga and Naturopathy:** Includes provision for grants to Central Council for Research in Yoga and Naturopathy, New Delhi, Morarji Desai National Institute of Yoga, New Delhi and National Institution of Naturopathy, Pune and other autonomous organisations

6. A lumpsum provision of Rs. 12 crores in BE 2001-2002 for projects/schemes for the benefit of N.E. Region and Sikkim has been included in this Demand.

7. **Others:** Includes four Central Sector Schemes, viz. (i) Upgradation of Deptts. of P.G. Training and Research in Indian Systems of Medicine, (ii) Upgradation of ISM and Homoeopathy undergraduate colleges; (iii) Development of Medicinal Plants Gardens and (iv) training of physicians, teachers, technicians and research workers in ISM and Homoeopathy and also Pharmacopoeial Laboratory in Indian Medicines, Ghaziabad, a subordinate office under the Department. Besides, it includes ongoing schemes like the International Exchange Programme, Information, Education and Communication, Extra Mural Research Project Survey Usage and acceptability of Indian Systems of Medicine & Homoeopathy system and State Drug Testing Laboratory and Pharmacies.

It also has provision for launching new schemes viz., Patent Cell, Speciality Clinics in Govt. Hospitals, National Board for Medicinal Plants, Information Technology, Pharmacy Councils, Ayurveda Park/ Panchkarma in Hotels and a National Ayurveda Hospitals in Delhi.

8. **Investment in Public Enterprises:** Indian Medicines Pharmaceutical Corporation, Ranikhet is a joint venture with Kumaon Mandal Vikas Nigam (A UP Government Undertaking) for supply of medicines of Indian systems of medicine and homoeopathy to Government institutions, etc. and sale in open Market.
